INSTRUCTIONS

1. Small Charity Support consists of providing autographed sports memorabilia for small organizations to utilize in their fundraising efforts. The program is currently **only available to charities located in New Hampshire, Massachusetts, and Rhode Island, and is subject to availability.** CFC expects to expand this program to other states in the future.
2. To receive item(s) in time for your Fundraising Event, you should **apply at least 6 weeks before the date of your Event,** if applicable.
3. Complete all of the information requested on the online application below. **You must complete the application online before printing.** Move your mouse over the Month Field in the Date at the top of the Application and click your left mouse button to begin typing. Use the Tab key to move from field to field. Move your mouse over a box and click to select the item. Click again to deselect. Complete all applicable fields, including the signatory's title, if known at the time.
4. Print the application. Make sure you use Adobe's print button, (upper left corner of the Adobe Menu), and not your browser's print command to print the application.
5. Have the application signed by a person in your organization who is authorized to do so.
6. On your organization's letterhead, send CFC a simple cover letter, one or two sentences are fine, along with the signed application to the following address:
